## **Mistress of the Propaganda:** (Dottie)

Website has been moved to the new free hosting. Domain transfer was \$14, Dottie just donated the fees but the house needs to be aware that is a yearly fee moving forward. GoDaddy account was closed. The new hosting allows for use of LetsEncrypt (Free SSL certificates). Total yearly costs have gone from \$300 for hosting our website to just a \$14 a year reoccurring charge.

# **OLD BUSINESS**

## Funds Program: (Anita)

Anita gave her presentation around the framework for a charity grant fund as a method of distribution of funds back to the community. This plan covered press releases, social media engagement, grant information, eligibility criteria, and what the requirements to apply should/may look like. There was an example application document, marketing plan, etc. A very thorough presentation and outline was prepared by Anita.

There was some confusion among house members around how much in funds was being allocated, if wording needed to be altered to ensure people didn't expect that just applying ensured grant acceptance or a specific dollar amount. Anita had given a rough timeline for looking at a June reveal of the grant program, but it was largely felt this was too soon and the House would set a later timeline after the grant is further fleshed out.

Changes were suggested and Anita made note of these and will represent the revised outline/Charity Fund Program structure at a future meeting.

### New Coronet (Helena)

The House proposed to Helena that we look at adding an additional coronet to the House (due to the Alamo being a symbol of colonialism and not always having a positive connotation for everyone that encounters it) so that members would have an alternative coronet to officially wear. It was noted this is not to remove the Alamo coronet, as it is a piece of our history as a house. But as an additional coronet that is an option for members to wear. Helena believes she can complete this by August, roughly. A June meeting will be had to discuss ideas for the coronet and will present a mockup example of the ideas in July at which the members would vote. Helena will then complete the final version by August. Dottie will set up the zoom room for June 6th for the members to discuss ideas.

#### Website Status (Dottie)

Dottie did some digging and investigiating and will be creating a new category on the website of "Out to Pasture" which will contain members that left in good standing to move to other cities, etc, but the house still wants to reflect that they were a part of the house history.
